12 Description THE PRECISE DATE OF THE CONSTRUCTION ... IS ... THE SUMMER OF 1277.... THE SITE CHOSEN WAS A SMALL ROCKY PLATFORM EXTENDING ABOUT SOYDS INTO THE ... RIVER DEE, AND PARTLY OR HHOLLY COVERED AT EVERY HIGH TIDE. IN PLAN THE CASTLE IS AN ALMOST PERFECT S QUARE WITH ONE CORNER CUT OFF, HAVING 3 THREE QUARTER ENGAGED TOHERS AND ONE SEPARATE TOWER ... THE INNER WARD MEASURES 160' BY 145', AND IS ABOUT & ACRE IN AREA. THE CURTAIN WALLS

ARE ALIGNED NEARLY TO THE CARDINAL POINTS.

THE DISTINGUISHING FEATURE ... IS UNQUESTIONABLY THE SE TOWER. HHILE FORMING PART OF THE CONSTRUCTIVE SCHEME ... THIS TOWER IS NOT FITTED INTO THE STRUCTURE OF THE FORTRESS. IT STANDS AT THE SE CORNER, BUT A LITTLE OUTSIDE IT, THE S AND E CURTAINS AVOIDING IT BY A SWEEPING INHARD CURVE. IN THE CURVE IS A STRONG ABUTMENT OF MASONRY, UPON WHICH RESTED THE END OF THE DRAWBRIDGE CONNECTING THE TOWER WITH THE MAIN BODY OF THE CASTLE; OTHERNISE, IT WAS COMPLETELY ISOLATED ...

THE 3 OTHER TOHERS ARE FITTED INTO THE SEVERAL ANGLES OF THE WALLS, AND WOULD APPEAR TO BE ALLKE ... BUT THEY ARE NOW IN SUCH A RUINED CONDITION THAT IT IS DIFFICULT TO RECOVER THEIR DETAILS.





Demage sustained to edge of stone walk-way along top of abutment where it meets the timber footbridge leading into the Cestle. A small path leading below the eastern side of the footbridge, is causing minor surface erosion to the grass embankment leading down into the most. Minor items of litter in the interior of the south w. tower. Two small piece of stone noted in the base of the north e. tower. The wooden steps leading into this tower are marked by graffiti, & the fifth step from the base moves considerably forward when stor on. The wooden steps leading into the the Great Tower are also marked by graffiti. The ster at the south end of the footbridge leading into the tower is also unstable, S a bolt head is missing from one side. The " Great Tower " sign is also marked by graffiti, & minor litt & class fracments were evident in the base of the tower. A bicycle has also been dumped to the north of the Great Tower on the marsh ground. The south western tower is marked by a gap in the masonry between the wall & the western side of the tower. Rubbish has been dumped to the west of the footpath skirting the west side of the north w. tower. This inclu partly burnt timber, mattresses, S a pile of tarmac/coal waste which has been dug into. The Footpeth leading into the Castle grounds From Castle Dyke Street, requires some infill in <7.7 the summit of the causeway crossing the moat.

Description Text:	constructionisthe summer of 1277The site chosen was a small rocky platform extending about 50 yards into theRiver Dee, and partly or wholly covered at every tide. In plan the castle is an almost perfect square with one comer cut off, having 3 three quarter engaged towers and one separate towerThe Inner Ward measures 160' by 145', and is about half an acre in area. The curtain walls are aligned nearly to the cardinal points. The distinguishing featureis unquestionably the S.E. Tower. While forming part of the constructive schemeThis Tower is not fitted into the structure of the fortress. It stands at the S.E. comer, but a little outside it, the south and east curtains avoiding it by a sweeping inward curve. In the curve is a strong abutment of masonry, upon which rested the end of the drawbridge connecting the tower with the main body of the castle; otherwise, it was completely isolated The three other towers are fitted into the several angles of the walls, and would appear to be alikebut they are now in such a ruined condition that it is difficult to recover their details. <1.> Source: Desc. Text /D.O.E. //1976 R.P. / Flint Castle / Leaflet / <2.>: Flint Castle is built on a low promontory of sandstone rock among the marshes bordering the shores of the
	Dee. The approach from the town is by a stone-walled causeway leading over what was once marshland into the outer bailey of the castle. The wall on the further sidewas probably the base of a curtain wall surrounding the outer bailey, while the small remains of ancient masonryare fragments of the outer gateway to the castle. The red sandstone building until recently (1976) occupying most of the outer baileywas built in 1785 as a gaol. The entrance to the inner baileyis on the other side of the modern wooden bridge across the inner moat little is left (of the gatehouse), althoughunder the bridge 2 deep chases for the counterpoises of the drawbridge (can be seen). Beyondis the inner baileycompletely (or was) enclosed by the curtain wall. This is fairly well preserved only on the S. side. To the right is a wooden bridge leading across the moat into the Donjon.

ription Text: S.M.C. Visit to site. All five trenches have been excavated, back-filled & reseeded with turt. The back-fill material covering trench 1 on the eastern side of the moat contained fragments of Buckley pottery, glazed pottery sherds, willow pattern, brick fragments, leather shoes, a large iron bolt, & glass. The infill on trench 2 at the south eastern corner of the moat contained fragments of ridge tiles of modern date. Trench 3 infill contained fragments of glass and brick. The trench running from the wall to the outer rim of the ditch. Trench 4 infill contained fragments of slate, glass, pottery and tin. This trench was sited just north of the causeway crossing the moat from Castle Dyke Street, & ran from the wall southwards across the moat to the outer rim adjacent with the innner kerb of the pavement. Trench 5 sited to the north w. of the footpath & boundary wall crosses a former car park. The trench has been back-filled with stone, which is settling slightly below the layer of

	surrounding tarmac surface. There is a general problem with litter and vandalism on site. A small bicycle wheel & remains of a string mat have been dumped on the south western side of the moat. Blue paint has been thrown over the sandstone boundary wall adjacent to the footpath, opposite Salusbury Street. Northwards along the verge, within scheduled area, several black bags of garden waste have been dumped, along with sections of yellow plastic tubing, a rolled up mattress & a shower base. Northwards along the footpath, on the western side of the verge, a small pile of bricks has been recently dumped. The boundary wall adjoining the south side of the south west tower has been sprayed with graffiti. The 'Flint Castle' information board sited on the northern side of the outer ward has been sprayed with copper metallic paint & the perspex has been indented in several places. 	Conclusion
	Most of the problems highlighted in this report could be rectified in future work projects at the Castle, however the underlying problem of vandalism still needs to be addressed. The introduction of close monitoring cameras on site would prove a powerful deterent to potential vandals. The site should also be monitored on a weekly basis by the local Police Force, with a view to restoring some respect for the Castle amongst the local youth population who have been seen abusing the site for glue sniffing etc, by local members of the public.
	Further improvements on site could include the provision of well secured cast-iron benche & litter bins. Consideration could also be given to the employment of 1 local person from Flint who would be involved in general ground maintenance such as litter picking and gras cutting. The person employed could be provided with a "Uniform & Cap " to underline the importance of their work & to command some respect from members of the public. The provision of a few promotional posters & Guides of the Castle could be distributed for display throughout the local Schools, & a copy of the Castle Guide book provided for their School Reference Libraries.

The grounds to the west of the Castle have been further enhanced by the addition of shrub covered banks & low barrier rails defining the edge of the car park. A height restriction bar over the entrance to the car park prevents mis-use by commercial & itinerant vehicles; The western side of the grounds lies in close proximity to a new Business Park. The embankment below the South Western & North Western Towers & Curtain Wall are abundant with wild flowers. Red Poppy, Purple Thistle, Wild Daisy & a variety of grasses & herbage provide habitat for both moths & butterflies & enhance the overall appearance of the site.

The appearance of the outer Ward has been improved by the addition of a newly lined gravel path.

The North West Tower.

The North West Tower.

Spray graffiti marking north side of tower and minor vegetation supported in upper level of stonework. A few items of litter discarded in base of tower.

The North East Tower.

The outer cladding of the tower adjacent to the salt marsh is subject to erosion. Drinks cans and small branches need removing from the interior of the tower.

The South West Tower.

The exterior recess of the South Western Tower above the western embankment needs consolidation. Two small pieces of yellow sandstone lying on grass embankment within recess.

The Great Tower.

A new layer of chippings has been introduced at the edge of the Inner Ward below the staircase leading to the Great Tower. The iron railings leading into the Great Tower are paint flaked in parts. Stonework within the tower remains marked by fluorescent spray paint graffiti. Timber rails marked by felt pen graffiti. Great Tower sign and adjoining sandstone marked by felt pen graffiti. Light items of litter comprising paper, and polythene bottles and cans discarded on new gravel surface within base of tower. Charred wood and cans have been placed within the upper recess of the south inner wall of the tower.

Vacinity of the Walls of the Castle.

Two large pieces of sandstone and a lump of earth lying on top of the western embankment. The corner of the curtain wall adjoining the South Wester Tower is smoke blackened and the ground immediately below the foundations of the wall should be raked to remove broken sections of plant pot, coloured electrical wire and broken cans.

Plantlife taking hold in masonry of outer curtain wall. A few items of litter and two traffic cones discarded along the embankment and below the western exterior of the North West Tower.

An ash tree sapling growing at the edge of the west curtain wall and two stones lying on the embankment mark an area where the outer stone cladding is missing. Some undermining of the curtain wall adjoining the North Western Tower is evident at this point. Dumping has occured in the area below the North West Tower where pieces of melamine covered hardboard; debris from a rabbit hutch; shoes and boots have been discarded. Light litter marking northern embankment and small sections of barrier rail and traffic cones. The outer cladding of the north curtain wall needs restoring in two places. One upper section of wall which can be walked over is unsupported over an area of approximately 2 M.

The Inner Ward.

Graffiti has been partly cleaned from the Inner Ward sign. A stone was in evidence lying on the area of lawn adjacent to the bench on the western side of the Inner Ward. A new layer of gravel has been introduced below the bench. The bench is paint flaked and marked by graffiti. The recess adjacent to the bench remains smoke blackened. Graffiti marking walls above the causeway leading into the Inner Ward.

	Problems associated with litter, grafftiti and vandalism on site could be reduced by the employment of a Grounds Man, on daily duty at the Castle. A small mobile office could be brought daily to the site, with Castle leaflets & small publications on sale for the public, particularly in the summer season.
	A security gate raised across the causeway leading into the Inner Ward could be kept locked at night to deter youths entering the Castle interior out of daylight hours, when much of the vandalism appears to be undertaken.
	Visual improvements to the grounds could include the sowing of a more indigenous form o grass seed in the north eastern end of the outer moat, or alternatively planting sedge grass
	seedlings resilient to salt water. Reseeding and earthwork repair could be usefully undertaken on the south eastern corner of the outer moat and the western side of the causeway leading onto the outer ward from the Castle Dyke Street direction. Litter picking and ground maintenance should continue to be encouraged on a regular basis, as the general improvements around the perimeter of the site, reflects well on the overall aspect of
	the Castle. Consolidation work should be considered along the outer areas of the north and western curtain walls where the outer cladding has broken away, and to an area of unsupported masonry on the upper level of the north curtain wall.
	Smoke blackened stonework could also be cleaned within the Inner Ward of the Castle. Gravel introduced around the base of timber steps and below the bench within the Inner Ward of the Castle could be replaced by more permanent sets of sandstone slabs embedded in the turf.
