

NOTE

The following 'report' (*CPAT Report 247*) was compiled, by CPAT, as an explanatory note to accompany digital data provided by CPAT and GAT as part of the Countryside Council for Wales' LANDMAP pilot project for Llanbrynmair, and as such is not a report on that process. Copies of the digital data that these notes refer to are held as parts of the Clwyd-Powys Archaeological Trust and Gwynedd Archaeological Trust Sites and Monuments Records.

Introduction

The Llanbrynmair Pilot area is characteristic Mid Wales Upland much of which lies over 200m OD. It is divided into three blocks by the wide but relatively steep sided valleys of the Dyfi river and its southern tributary the Twymyn. The northern most block above Dinas Mawddwy rises to over 600m while the southernmost only reaches 300m. The vegetation is similarly characteristic being upland pasture with moorland and pockets of forestry, and more orderly lowland pasture occupying the main river valleys. The predominant agricultural regime is (and almost certainly always has been) sheep husbandry.

On to this area a number of landscapes have been drawn. These landscapes are defined by a number of themes set out in the LANDMAP guidelines. The quality and nature of definition of their boundaries varies, some following current field patterns (where these are relevant), some following local topography and some being quite arbitrary. They are drawn with reference to their commonality of archaeological and historical features and processes and their characteristic landform. The information about these various archaeological and historical components comes from the regional Sites and Monuments Records of the Clwyd-Powys Archaeological Trust and the Gwynedd Archaeological Trust and the particular local knowledge of these Trusts' staff. While a certain level of confidence can be expressed in the resulting landscapes, they are certainly character areas as far as their content goes, they cannot be seen as finite entities as the quality of the base record varies greatly and further research in almost any area would inevitably change the perception of its archaeological and historical content and consequently lead to a redrawing of boundaries.

The nature of most of the drawn landscapes is self evident, as most of them are defined only with reference to their SMR content, and consequently these are described below collectively rather than in individual detail. Where discussion or explanation of a particular landscape is required (for example where landscapes are dependent on features not recorded in the SMR) this is highlighted in each thematic section.

Recorded sites from the base SMRs are represented by point data (ie symbols derived from a Foxpro database) within this system. No attempt has been made to map the actual area of sensitivity of individual sites as this would not be possible without extensive field work. However such an exercise would be useful to analysis and policy formation and perhaps should be considered in the future. Each of these point sites has been categorised by theme - as with the landscape areas.

It is difficult to express a level of confidence in this base record and therefore by implication. As with all SMRs the records here reflect the patterns of past research as much as they reflect any finite distribution of archaeology, and while some small areas have been researched in detail the majority of the study area has not been the subject of sustained archaeological work. As a rule of thumb it <u>might</u> be said that more recently a site (and therefore its immediate environs) has been visited the higher the level of confidence one might have in the record, but this is by no means universal. An impression of this 'index' can be obtained by plotting the dates at which sites on the record were last visited across the pilot area.

Time restrictions have meant that no new database records have been created for the LANDMAP pilot, even where a need for one has been identified.

The collected data has been prepared and presented in a digital format (MapInfo) as such data can only realistically be handled in this manner within the prescribed time table. A set of thematic paper maps is attached here to act as a key for the various digital files and for ease of reference outside any GIS.

Ritual & Symbolic landscapes

Nine landscape areas have been defined encompassing approximately 1588ha and representing some 6% of the pilot area. Their characteristic content is one of Bronze Age barrows and finds. They are predominantly upland and are distributed evenly throughout the pilot area.

In many respects these are perhaps the most arbitrary of all the landscapes considered, and therefore perhaps the most meaningless. Evidence of ritual and symbolism in the base record is severely limited (to easily recognised 'traditional' funerary monuments and datable chance finds) and this sepulchral bias is obvious in the resulting landscapes. It is almost certain that the ritual and symbolic landscapes of the prehistoric were extensive and highly complex but the current lack of evidence prevents their definition today in all but the most simplistic form.

The exception to this trend may be SN-P/H/6 which is based on the two stone circles of Cerrig Cearau and Lled Croen yr Ych, and their accompanying barrows, and is perhaps the only truly symbolic landscape considered. However even here as some doubt has been cast on the validity of the latter site, this area may not be such an exception as it first appears. Descriptions of the size and shape of this circle, written since 1911, vary dramatically and have led to some authorities concluding that it is a creation of Victorian fancy which has subsequently been remodelled by well meaning aesthetes (or practical jokers). If this is indeed the case it might be argued that this act, and tradition, of forgery itself comprises a cultural landscape.

Prehistoric industry

One landscape has been defined encompassing approximately 229ha and representing only about 0.9% of the pilot area. It is based on two areas of flint working straddling the head waters of the Afon Twymyn at Dylife.

Little can be said about this landscape. It is clear from the archaeological record that a prehistoric flint industry is present at Dylife. Worked flint debris and unworked pebbles have been noted eroding from peat areas on the valley sides. However it is impossible to say how extensive these industries might have been here, as this area is now much altered by later lead mining, or indeed to say what similar evidence might lie undiscovered elsewhere in the pilot area. It is interesting to note that here, as elsewhere in Powys, this area appears to have nothing in the way of prehistoric funerary or settlement monuments.

The following area has been defined as a landscape.

Roman activity

One landscape has been defined encompassing approximately 221ha and representing some 0.8% of the pilot area. It is based on the Roman signal station and Roman road at Penycrogbren above the Dylife mine.

It is assumed, though conclusively proved, that the Penycrogbren signal station and local Roman road system belong to an area of roman lead mining at Dylife. It is difficult to define this area however because of extensive Post Medieval lead mining activity.

The hypothetical line of a second roman road does cross into the pilot area at Bwlch Y Fedwyn but no evidence of this feature survives on the ground and although this has been identified in the database no related landscape has been defined. Both stretches of road have been given a number for ease of reference.

Settlement

Twenty one settlement areas have been defined. These encompass both modern settlement areas and what are thought to be the cores of earlier historic settlements. Without exception these settlements lie in the main river valleys.

Seven historic settlement areas have been defined encompassing approximately 26ha and representing only 0.1% of the pilot area. Of these Cemmaes, Llan, Mallwyd and Llanmawdwy are small nucleated settlements attached to early churches. Tafolwern is little more than an isolated motte, but it would appear to have been the anglo-norman forerunner of the neighbouring Llanbrynmair. Dinas Mawddwy has a characteristically medieval street pattern and is mentioned in documentation from the C15th onwards and is presumably a later medieval creation. Wern-Gerhynt is the exception to this group being an extensively shrunken, and now largely deserted, settlement of the early post medieval period. Its origins are unclear but it may be a failed encroachment on to adjoining Common land.

The remaining fourteen settlements fall into a number of categories and encompass approximately 136ha, representing some 0.5% of the pilot area. Cemmaes, Llan, Dinas Mawddwy and Mallwyd are merely post medieval and modern extensions of their early historic cores. Aberangell may also belong to this group, but no evidence was available in this survey to assess early settlement here. Talerddig appears in early documentation and appears to have existed by the C14th (as part of the Cistercian estate of Tirymynach belonging to Strata Marcella abbey), however no physical evidence of this period survives and the present settlement is the result of the C18th & C19th wool trade. The local wool and flannel industries would also appear to be responsible for the present forms of Bontdolgadfan, Cwm Llinau, Cwm Pennant (and its satellite Pentre Cilcwm), and possibly also Llanbrynmair (as a 'replacement for the earlier Llan to the south). Cemmaes Road may be the only wholly modern settlement, appearing around a railway halt, as its name suggests, in the C19th.

Ecclesiastical and monastic landscapes

Five landscapes have been identified. These are exclusively drawn from records of Cistercian land holdings which, by chance, occupy the better quality upland pasture on the fringes of the pilot area (being either farming or manorial holdings). However as these estates' common ownership and landuse during the medieval period has obviously shaped their subsequent (and indeed current) nature they should be considered as distinct landscapes.

These landscapes are defined from documentary sources which have little or no physical remnants. However it is interesting to note the correlation between a number of church or ecclesiastical sites in the SMRs and these Cistercian estates - for example the Ffynnon Rhiwr Cawr holy well or the Bryn y Groes placename. Tirymynach is the only estate to have a notable archaeological presence in that it contains the manor and settlement of Talerddig and is bounded on the north by the Abbot's Dyke mentioned in medieval documentation.

Information was not available to this survey about the estates of other monastic orders, as it has not been studied and published in the manner of the Cistercian evidence, but these would undoubtedly reveal other potential landscapes.

Defence

No landscapes have been defined in this category.

The only bona fide defence site within the area is the motte at Tafolwern. While this is clearly a medieval defensive feature on its own it does not readily translate itself into a landscape. Other possible candidates were the Roman fortlet (possibly a signal station) at Penycrogbren, which on consideration has been given its own *Roman* landscape - as it may be more dependent on early mining than on defence. Neither the documented hillfort at Moel Eiddew, which as it cannot be traced on the ground, nor the dubious medieval castle site of Castell Cyfeiliog, which only survives as a confused reference in the Royal Commission on Ancient and Historic Monuments in Wales' 1911 inventory, can bare definition as a landscape, though both (if real) would certainly have to be considered.

Communication

One landscape of communication has been defined. This is the course of the Cambrian railway, which passes along the Twymyn and Dyfi valleys crossing the area from east to west. The boundary of this landscape is somewhat arbitrary, and is defined as a broad ribbon centred on the railway and covering some 68ha (0.25%) of the pilot area.

The Cambrian Railway built during the 1860s to connect Shrewsbury to Aberystwyth, forms a particularly fine 'industrial archaeological' monument, with sweeping stretches of cutting and embankment and a large number of impressive stone bridges and viaducts and other feats of engineering along its length. It is it one of the most striking features of the pilot area and forms its own narrow linear landscape.

Consideration was given to plotting the course of the various Turnpike roads that cross the area, but insufficient time was available within the pilot project to allow appropriate data to be collected. This, and the plotting of other significant roads should form a part of any future scheme.

Resources

Nine resource based landscapes have been defined encompassing approximately 58848ha and representing some 22.5% of the pilot area. With one exception these are related to mining and quarrying and are concentrated in the upland to the west of the pilot area. The majority of the mines noted are lead or copper although zinc was mined at Dylife and some Silver at Craigwen. The quarries are mostly small, local concerns.

The mining and quarrying falls in three main areas. The Craigwen mines in the high upland block of southern Gwynedd where works are characterised by dispersed areas of shafts and levels, with stone quarries, and this landscape dominates the northern part of the pilot area.

In the south extensive areas of lead mining exist around Dylife and Penycrogbren and Llannerch-yr-aur. Here quarrying, open cast and deep mining have been practiced since at least the C12th (a Cistercian boundary charter for the adjoining Cwm Llwyd area details the monks' rights 'both above and below the ground') and is suspected to have Roman origins. The Dylife mine was the most important of these mining areas and was once one of the largest lead mines in mid Wales. It is particularly notable for the remains of its self contained mining settlement which even included a church. Today this landscape is dominated by the remains of 300 years full scale mining and shafts, levels, engine houses and the like dot the area around the now deserted village.

One area of peat extraction has been defined at Moel Eiddew where evidence of peat cuttings and peat stands are spread over a large area of this local summit. One further area of peat cutting was noted during this survey just outside the pilot area to the north west of Llanmawddwy, though this has not been defined as a landscape.

Within the terms of the LANDMAP process their will obviously be other resource landscapes within the pilot area. A lack of time to assemble the appropriate evidence for these, has precluded any attempt to define them.

Subsistence

Four landscapes have been defined. These are subdivided into two types, upland (at 11953ha, and representing some 46% of the pilot area, being by far the largest of any of the landscapes defined) and lowland (approximately 7249ha and representing some 27% of the pilot area).

It could, and perhaps should, be argued that all the pilot area should fall into a subsistence landscape. In the past the area has always been one of pastoral subsistence and today is still dominated by sheep farming having little or no other industrial or commercial enterprise. What 'industry' there was such as wool processing and flannel production was totally depended on this pastoral subsistence economy. However for the purposes of LANDMAP landscapes have only been drawn where they can contain tangible 'archaeological records', which even so has lead to approximately 90% of the pilot area falling into one of these two categories.

The archaeological and historical records of this rural economy divide sharply into two zones - upland and lowland. In view of this the 200m contour was chosen to define the boundary between these two zones. It is appreciated that this is a rather arbitrary line and that given time it could be redrawn to follow existing (and previous) land division - but this cannot be achieved within the limited time scale of this pilot.

The upland subsistence zone is characterised by abandoned hafotai and deserted farmsteads with areas of resource exploitation (such as quarrying, mining and peat cutting). Much of the landscape has remained unenclosed until relatively recently.

The archaeology of the lowland subsistence zone is characterised by a greater range of agricultural buildings and structures, which may be as old as their upland counterparts but which tend to remain in use. The zone contains all the evidence for the wool and cloth processing and other agri-industries and the majority of the area's infrastructure such as road and rail links, and all its major settlement. The landuse pattern is one of enclosure in small well established fields.

Common Land

Twenty nine registered Commons exist within the pilot area, encompassing some 1828ha, and these have been drawn as part of the LANDMAP process.

Although their only common feature is their legal status, rather than any physical attribute, these areas have been included here as their shared landuse brings a degree of landscape stability that is often absent elsewhere, and in this sense they should be considered as discrete landscapes in their own right.

With a few exceptions, such as Trannon Moor the largest Common in the pilot area which lies wholly in upland, the Commons tend to occur at the junction of the upland and lowland subsistence zones. Commons that do lie wholly within this lowland zone tend to adjoin areas of settlement, such as at Commins Coch, Cwm Llinau, Aberangell and Dinas Mawddwy.

Cultural associations

Two cultural landscapes have been defined encompassing approximately 149ha and representing some 0.5% of the pilot area. These are the Gorsedd circle at Llanbrynmair, erected in recent years as part of the Montgomeryshire Eisteddfod, and the area around Penecrogbren gibbet. Neither of these 'sites' are recorded on the SMR.

Unfortunately the SMRs do not record the cultural associations of landscape and therefore it is virtually impossible to define this type of landscape from this source. It is certain that many more cultural landscapes exist within the pilot area, but further research will be necessary to identify and map these.

Penycrogbren is the centre of many local folk tales, the most famous of which dates to around 1700 and concerns the local blacksmith who murdered his wife and daughter and threw their bodies down a mineshaft. He was arrested and when found guilty was forced to make his own head and body cages and the gibbet iron, before he was hanged for his crimes. In the 1930's the iron head cage with the skull still inside was found at Penygrogbren, and is now kept at the Welsh Folk Museum at St.Fagan's. The site of the gibbet is still visible as a low mound on the high ridge-way overlooking the isolated Inn that is all that now remains of the long abandoned mining settlement of Dylife.








Title - existing SMR data mapped by date of last visit



Title - all data points and all landscape areas mapped by theme




